6. Cardiac Arrest

Dr. Sandra Jenneson provided a comprehensive review of the BCEHS response to calls where Cardiac Arrest is suspecting. Her presentation was pre-circulated in the agenda package.

She reported that the cardiac arrest database is reviewed daily and monthly. Dr. Jenneson emphasized the importance of quick action by witnesses and bystanders since patient outcomes were significantly better when quick CPR was commenced. She reported that starting this year, it will be compulsory for students to learn CPR prior to graduating, right now 90% of public schools offer CPR learning.

The PulsePoint app is a 911-connected app that can immediately inform you of emergencies occurring in your community and request your help when CPR is needed nearby. AED locations will be disclosed when cardiac arrest events occur. In remote areas, "neighbors saving neighbors" is being introduced. 911 call takers are being trained to give CPR information over the phone.
